MEMBERSHIP PRIVILEGES

For the benefit of the current membership and prospective members, the categorical listing below describes the Membership entitlements and benefits of the Fresno Yacht Club.

a. **Full Members**:** Those individuals choosing Full Member status shall be provided, but not limited to, the following benefits:

1. Each "Full Membership" shall include the spouse and unmarried children, under twenty-one years of age, of each member.
2. There shall be no cost for participating in racing events held on Millerton Lake excepting Invitational Regattas (e.g. High Sierra Regatta).
3. Each "Full Members" shall be entitled to only one (1) vote on matters that come before the General Membership, regardless of the number of family members or number of boats.
4. Full Members shall receive the monthly published Mainsheet.
5. Shall be scored, when participating in FYC Racing activities.
6. Shall be affiliated with a recognized Sailing Association.
7. Shall be eligible for full Club discount associated with annual US Sailing Membership.
8. Shall have access to and utilization of FYC equipment as defined in §3.1, Fresno Yacht Club Policies, Use of FYC Equipment.
9. Presentation of Annual Fresno Yacht Club Roster.

b. **Associate Members:** Those individuals choosing Associate Members shall be provided, but not limited to, the following benefits:

1. Each "Associate Membership" shall include only one individual.
2. Each "Associate Members" shall not be entitled to vote on matters that come before the General Membership.
3. "Associate Member" shall receive the monthly published Mainsheet.
4. The Associate Members shall not be affiliated with FYC as a recognized Sailing Assoc.
5. Shall be eligible for a discount on the annual US Sailing Membership, at a rate of ½ of full FYC discount (Please refer to Membership Fee Structure).
6. Presentation of Annual Fresno Yacht Club Roster.

c. **Junior Members:** Those individuals choosing Junior Membership status shall be provided, but not limited to, the following benefits:

1. Junior Members shall receive the monthly published Mainsheet.
2. There shall be no cost for participating in racing events held on Millerton Lake excepting Invitational Regattas (e.g. High Sierra Regatta).
3. Shall be scored, when participating in FYC Racing activities.
4. Shall be affiliated with a recognized Sailing Association.
5. Shall be eligible for full Club discount associated with annual US Sailing Membership.
6. Shall have conditional access to and utilization of FYC equipment as defined in §3.1, Fresno Yacht Club Policies, Use of FYC Equipment.
7. Presentation of Annual Fresno Yacht Club Roster.

d. **Life Members**:** Those eligible for “Life Membership” status shall be provided, but not limited to, the following benefits:

1. Each “**Life Member**” shall include the spouse and unmarried children, under twenty-one years of age, of each member.
2. There shall be no cost for participating in racing events held on Millerton Lake excepting Invitational Regattas (e.g. High Sierra Regatta).
3. Each “**Life Member**” shall be entitled to only one (1) vote on matters that come before the General Membership, regardless of the number of family members or number of boats.
4. **Life Member** shall receive the monthly published Mainsheet.
5. Shall be scored, when participating in FYC Racing activities.
6. Shall be affiliated with a recognized Sailing Association.
7. Shall be eligible for full Club discount associated with annual US Sailing Membership.
8. Shall have access to and utilization of FYC equipment as defined in §3.1, Fresno Yacht Club Policies, Use of FYC Equipment.
9. Presentation of Annual Fresno Yacht Club Roster.

NOTE:

* For new Full and Associate Membership the initiation fee is twenty-five (\$25.00) dollars.

** Life Members are those who have maintained full or associate membership in the Fresno Yacht Club for a cumulative period of 35 years or more.
